SUSTAINABLE IMPACT. THE COMMUNITY-BASED PROJECTS INCLUDE: ORPHANS AND VULNERABLE
CHILDREN PROGRAMS; EARLY CHILDHOOD EDUCATION PROGRAMS; PRIMARY HEALTH INITIATIVES
SUCH AS CHURCH-BASED CLINICS, HIV/AIDS PREVENTION, HOME-BASED CARE FOR HIV/AIDS
PATIENTS, WATER AND SANITATION PROGRAMS, AND NUTRITION PROGRAMS; AS WELL AS ECONOMIC
EMPOWERMENT PROJECTS; AND LEADERSHIP DEVELOPMENT.
